PER CURIAM. The state appeals a pretrial order dismissing the information charging Glenn Jones  
with battery. We reverse. Jones was charged with attempted second-degree murder for shooting and  
killing his brother. He moved to dismiss the information, claiming that the nature of the crime  
charged would permit the state to bring a charge for simple battery; that the information failed to  
state a forcible felony to support attempted murder; and, therefore, it was defective and must be  
dismissed. The state did not allege the involvement of a firearm. Jones was charged with battery  
under § 784.03, Florida Statutes (1987): ... 784.03 Battery. ¶ (1) A person who willfully and  
knowingly makes or causes to be made an offensive or harmful contact
